## **Terms and Conditions of 9<sup>th</sup> Rybna Palace Master Classes organised by the Rybna Palace Institution of Culture**

1. The 9<sup>th</sup> Rybna Palace Master Classes ('the Class(es)') are organised by the Rybna Palace Institution of Culture, ul. Powstańców Warszawskich 90, 42-680 Tarnowskie Góry, Poland, NIP [Tax ID] 645-25-24-437, ('the Organiser').
2. The Masterclasses is series of paid workshops, held at the Organiser's premises, as part of which the participating student artists ('the Participant(s)') train under the tutelage of a Master designated by the Organiser. The accommodation and board arrangements are detailed in the promotional materials for each class. The dates of particular Classes are available on the Organiser's website and Facebook page. The deadline for submitting applications is specified on the Organiser's website.
3. The Master Classes are only available to paying Participants. The fees and payment details are available from the promotional materials for each Class.
4. To apply, please email a duly completed application form (available from the Organiser's website) to [info@palacrybna.pl](mailto:info@palacrybna.pl).
5. The full fee must be paid by bank transfer to the Organiser's bank account (stating the participant's name and full name of the Class) within the time specified in the promotional materials.
6. In the event of cancellation 30 days or more prior to the Class commencement date, the Organizer shall refund the full fee paid by the Participant.
7. In the event of cancellation less than 30 days prior to the Class commencement date, the Organizer shall not be liable to refund any part of the fee paid by the Participant.
8. The Organiser shall have the right to cancel the Classes due to insufficient participant numbers. In such a case, all Participants shall be duly notified of such and shall receive a full refund of the fee paid regardless of the date of payment. Such reimbursement shall be made within 7 days of cancellation.
9. Participants accepted to attend the Class are obliged to present themselves at the time and venue specified by the Organiser. Failure to do so, even if justified, shall not constitute valid grounds for any fee reimbursement claims.
10. Minors may participate in the Classes only upon written consent of their legal guardians, using the relevant consent form available on the Organiser's website along with the application form.
11. The Organizer shall not be held responsible for any incidents beyond the Organiser's control, which may arise throughout the duration of the Class.
12. The Organiser shall have the right to document the Classes with image and sound recording equipment for use in promotional materials and web-based broadcasts.
13. Any changes to these Terms and Conditions shall be null and void unless made in writing.
